6. Citizens will follow the decorum policy.
7. Debate or argument between parties in the audience will not be allowed.
8. Certain legal issues may not be discussed. (Examples include but are not limited to personnel issues, lawsuits, etc.)
9. Violation of this public comment policy will result in the citizen being directed to cease or resume sitting.

BACKGROUND

At the June 15, 2015, City Commission meeting, the City Commission approved setting July 20, 2015 as the sale date of General Obligation bonds for the long-term funding of capital improvement projects in the City of El Dorado.

Written and electronic bids will be received on behalf of the Clerk of the City of El Dorado, Kansas until 11:00 a.m., Central Standard Time, on June 20, 2015 for the purchase of the above-referenced bonds. The bids will be opened at the close of the bidding period.
